Dear Members:

It seems like it has been a long time since we were all enjoying the summer together. With our recent snow fall, I can't help but look forward to warmer weather and a dip in the pool!

Enclosed you will find your membership renewal packet for the 2010 season. If you register by April 1st for a **Family, Couple, Senior or Pre Senior** membership, you will receive a discount of \$50 off of the regular membership price. Please see the enclosed Rates and Benefits Chart for exact rates. Memberships are valid from May 1 to April 30 of the following year per Article IV of the Bylaws.

The board is happy to announce that members will have the option to avoid an increase in last year's membership fees simply by helping CCERA to raise funds to purchase replacement lounge chairs. Currently our membership income is not adequate to maintain CCERA property, run the pool during the summer season, and purchase necessary replacement equipment, or make major repairs. Last year we had great success with our raffle, raising over \$5000. This money was used to purchase a riding mower to maintain the grounds.

In your membership package you will find 2 raffle tickets. We are giving members the option of **either selling the 2 tickets to maintain last year's membership fees, or purchasing the tickets as a contribution** towards the purchase of new chairs for the pool area. Board members found these tickets easy to sell last year by letting people know that CCERA is a not for profit organization, that allows local nonprofit organizations to use our hall and pool at no charge. We need everyone's help in this fundraiser. If you could sell or buy more than two tickets, please contact Paul Shannon at 410-761-0243. The stubs for sold tickets, as well as the money for their purchase need to be returned to CCERA by May 1st, 2010 so that the chairs can be ordered and delivered by opening day.

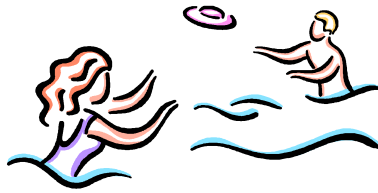

A list of jobs that need to be completed will be posted on our website prior to May 1st.

Registration for the 2010 Pool Season

The pool will open for the season on Saturday, May 29th at noon. The pool will be open from 12:00 until 8:00 on May 29th, 30th and 31st. We will celebrate Memorial Day with our annual cook-out, courtesy of our resident chef, Paul Shannon. Hot dogs and hamburgers will be offered at a reasonable price on Saturday (rain date Monday). Bring a covered dish or dessert to share if you like.

After the holiday weekend, and until school is over for the summer, the pool will be open after school hours during the week. It will open at noon on the weekends. Please see the events calendar for the schedule of weekday and weekend hours.

A registration form is enclosed for your convenience. Discounted rates for Early Bird registration will be applied for those who mail their registration forms by April 1, 2010.

Membership packages, including boat ramp memberships, will be available at the Guard Shack starting Memorial Day weekend for those who take advantage of Early Bird registration or register at least one week prior to pool opening. While we will make every effort to process all registrations that are received before opening day so that Membership packages are available for the holiday weekend, please remember that it can take up to 7 days to process registrations once they are received. **We strongly recommend that you mail your registration and payment so to arrive by May 7th, along with your raffle ticket money so that we can have your Membership Package available to you on opening day.**

Membership dues can be paid by check, money order or credit card. If you wish to pay by credit card, please check the appropriate box on the registration form. Be sure to include a phone number so that we can call you to obtain your credit card information.

When filling out your registration form, please remember that a family is defined as living at a single address. A couple is defined as two people who live at the same address, and may consist of a parent and child. Proof of residence may be required for all memberships other than boat ramp or single. Please remember that Swim Team league (not CCERA) rules dictate that **Swim Team members must be part of a family membership.**

As always, all children under 12 must be accompanied by an adult at all times. All children must take the swim test administered by a life guard in order to swim in the deep end of the pool. No child under 12 will be allowed in the deep end without having passed the test.

If you are planning on having a party at the pool, Life **Guards must be notified two weeks in advance** so that proper coverage can be scheduled. You may purchase extra guest passes in advance. As in the past, we request that no cash be exchanged with life guards, but you may purchase the guest passes from Tom Forsyth or the guards by (Member Check) only.

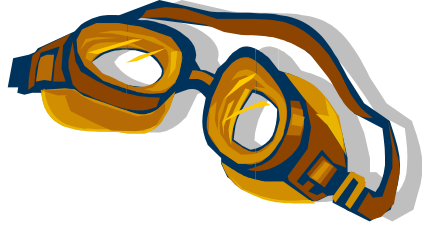
